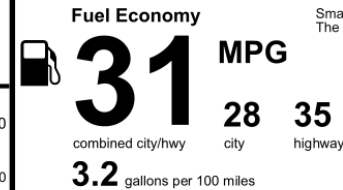

Gasoline Vehicle

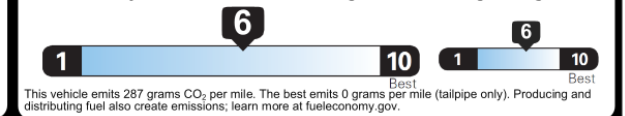
